- candidate must fulfill all the eligibility criteria mentioned in the Regulations for Different Programmes of the Faculty of Engineering Technology & Management, University of Kalyani for B.Tech programme.

D. GENERAL INSTRUCTIONS:

1. All photocopies MUST be self-attested.
2. Student must pay the admission fee at the time of admission. If the payment is not made at the time of admission the candidature may be cancelled automatically without further information.
3. If at any stage of admission the information furnished by the candidate is found to be incomplete, false or incorrect, the University of Kalyani shall have full authority to cancel the admission without further notice.
