## West Bengal Act XII of 2001<sup>1</sup> THE KALYANI UNIVERSITY (AMENDMENT) ACT, 2001.

[Passed by the West Bengal Legislature.]

An Act to amend the Kalyani University Act, 1981.

West Ben. Act XL of 1981. WHEREAS it is expedient to amend the Kalyani University Act, 1981, for the purposes and in the manner hereinafter appearing;

It is hereby enacted in the Fifty-second Year of the Republic of India, by the Legislature of West Bengal, as follows:—

- 1. (1) This Act may be called the Kalyani University (Amendment) Act, 2001.
  - (2) It shall come into force at once.
  - 2. In section 22 of the Kalyani University Act,-
    - (a) for sub-clause (vi) of sub-section (2), the following subclause shall be substituted:—
      - "(vi) five Teachers of the University, not being Professors, from the Departments of the University under the Faculty Council for post-graduate studies concerned, elected jointly by such Teachers from amongst themselves:

Provided that not more than one such Teacher shall be elected from any such Department;", and

- (b) for sub-clause (vi) of sub-section (3), the following subclause shall be substituted:—
  - "(vi) two Teachers of the University, not being Professors, from the Departments of the University under the Faculty Council for post-graduate studies concerned, elected jointly by such Teachers from amongst themselves:

Provided that not more than one such Teacher shall be elected from any such Department.".

## Statement of Objects and Reasons on the Kalyani University (Amendment) Bill, 2001 (Bill No. 14 of 2001).

## STATEMENT OF OBJECTS AND REASONS.

It was provided in the Kalyani University Act, 1981 (West Ben. Act XL of 1981), as amended up to 1999, that there shall be Faculty Councils for post-graduate studies comprising along with other members, Teachers of the University (not being a Professor). It was also provided that there shall be only one Teacher as member to the Faculty Councils for postgraduate studies in (a) Arts and Commerce, (b) Science and three Teachers as members to the Faculty Councils for post-graduate studies in (c) Education, (d) Engineering, Technology and Management, (e) Law and (f) Music and Fine Arts.

- 2. That the number of departments in the Faculty Councils for postgraduate studies in (a) Arts and Commerce, and (b) Science is more than the number of departments in the Faculty Councils for post-graduate studies in (a) Education, (b) Engineering, Technology and Management, (c) Law and (d) Music and Fine Arts.
- 3. Consequently, the existing representation of Teachers (not being Professors) to the Faculty Councils is not properly carried out and hence to remove this disparity, it is necessary to amend the Kalyani University Act, 1981 (West Ben. Act XL of 1981).
  - 4. The Bill has been framed with the above object in view.
- 5. There is no financial implication involved in the Bill.
