2.3.2 – Students mentoring system available in the institution? Give details. (maximum 500 words)

Different Academic Departments in the University take recourse to different mentoring methods for their students which commonly include the emphasis on enhancement of the institutional ambience while creating homely atmosphere as the students learn their concerned subjects. Some Departments undertake guided research projects in the final semester of the PG Course – notable among them is the Botany Department. Also, students are encouraged to give seminars as part of internal assessment. Also, in some Departments students are grouped under the mentorship of the individual faculty. A Students' Mentoring Shell (SMS) consisting of all the faculty members of the Department of Molecular Biology and Bio-technology has been created. Each faculty is the guardian or mentor of 5-6 students and he or she usually interacts frequently with the student as they accustomed to a new environment and academic schedule of the post graduation course. The SMS perform the following activities throughout the year: The other mentoring activities include encouragement to students in participation of workshops, seminars and like. The students are continuously motivated as they can go to the higher studies after cracking all India Research entrance test like GATE, NET, SET etc. The courses offered by the Departments would help the aspirant graduates in getting a broad based knowledge about theoretical and applied aspects of different disciplines of their subjects in general and its frontier areas in particular. It is aimed at offering high quality training and generating expertise in the frontier areas of the subjects, and to provide appreciative atmosphere to the bright young talents. The courses in some Science Departments include interalia, collaborative efforts with different institutes, industries, clinical laboratories and other agencies. The Department of Microbiology has already developed its infrastructure with some sophisticated equipment like, fermentor, UV- vis spectrophotometer, PCR/RT PCR thermocycler, ELISA Reader, BOD chamber, cold centrifuge, Gel-documentation, Phase contrast microscope, Fluorescence microscope, Atomic Absorption Spectrometer, Low-volume spectrophotometer, Ion-chromatography, Anaerobic-microbial culture chamber etc. The interdisciplinary nature of our research is reflected in our faculty members, who have shown their collaborative approaches with the other laboratories both at National and International levels (University of

Calcutta, Bose Institute, IISER-Kolkata, Bidhan Chandra Krishi Viswavidyalaya, Central Inland Fishery Research Institute, Tripura University, WB State University, Nagoya University, Chittaranjan National Cancer Institute). Physical education is a teacher's training course which requires continuous monitoring of the students activity both in the classrooms as well as in the ground also. Students are continuously monitored in two times at the ground and lab practical classes. Besides those students who are participating in all India intervarsity tournaments there are separate coaches and instructors for catering there sports skills and monitoring of sports performances.

All the laboratories are maintained by the department staff and financed by the finance department of the University. At the time of purchasing new equipment through central purchase committee by inviting tender (E-tender) as the case may be. Initially, a MoU is signed between the University and the company supplying the instrument for repairing purposes. Instruments procured from project funds are maintained repaired by the overhead funds. Laboratory instruments are used by the students and scholars of the department. The instruments in the research laboratories are utilized by the research students of the department and research students from other departments of the University by requisition. Library: The University owns a Central library as well as a reference library in the department. The collection in the central library comprises of books and journal for PG students, teachers and research scholars, e-journals, Monograms and Articles, Ph.D. theses and M.Phil. Dissertations. The financial assistance as granted by UGC and State Govt. are utilized to purchase books and e-journals and other contingent materials. All the activities of the central library including lending and collecting of all the documents are discharged by the staff of the central library. Computers: Computers are maintained centrally by the Centre for Information Resource Management (CIRM) of the University. Technicians of the CIRM install repairs and maintain the LAN system of the University. Purchase of new computers is through central Purchase Committee. Development Officer of the University monitors all purchase of computers instruments. All stakeholder of the University utilize these computers for official, teaching research purpose. Regular seminars are held in the departments for the

	students. Tutorial classes are held for weaker students as a means of doubt clearing. In visual Arts department, regular Art Exhibition, Art Camp are organised as a part of their academic performance.
Examination and Evaluation	? As per the University Regulation, during every academic year the departments conduct at least one internal assessment examination one end semester examination. However, application forms are received and verified manually to prepare the merit list. 60 seats are reserved for the home university students and 40 seats are for the students of other Universities. For students of other Universities, an entrance examination is held and a merit list is prepared based on entrance examination marks plus final examination marks. The whole process is transparent and status of all applicants is displayed on the University website.
Curriculum Development	In the affiliated colleges of the University, the new CBCS syllabus has been introduced after thorough discussion in the Under Board of Studies (UGBOS). Post graduate courses at the departments of the University are updated and revised by the Post Graduate Board of Studies of the departments and are approved in the Faculty Council meeting of the respective faculties after thorough discussion and deliberation.

7.1.7 – Initiatives taken by the institution to make the campus eco-friendly (at least five)

Green campus initiatives with focus on biodiversity conservation: The University of Kalyani has always been known for its lush green campus and all its stakeholders are blessed with access to an extremely clean and green environment. The University always promotes the maintenance and sustenance of the natural greenery and inherent biodiversity of the campus. The University of Kalyani has established and has been maintaining an 'Ecopark' since 2011 with initial support from the Department of Environment and Department of Forest, Govt. of West Bengal. The major trees, shrubs and herbs in the University campus and surrounding have been surveyed and documented. In the present year, the University initiated the establishment of a Butterfly Garden and a Herbal Garden within its campus with funds from West Bengal Biodiversity Board, Govt. of West Bengal and Ministry of AYUSH, Govt. of India. The University strives to maintain its inherent biodiversity and create habitat for more of such flora and fauna.

Green campus initiatives with focus on energy conservation: The University is making conscious effort for energy conservation. All the stake holders are being educated to switch off electric points whenever the utility of the point is not absolutely necessary. Everyone is advised to switch off the computer when not in use. The university is switching over to low power consuming lamps like CFL lamps and LED lamps as far as practicable. The University has also planned to use renewable source of energy especially solar energy for some of its lighting and heating requirements and plans to switch to solar energy sources in a big way in near future. The Ecopark is already lighted with solar energy.

Water harvesting: The University also has making conscious effort for water conservation. There are some rainwater harvesting and natural recharge of groundwater ponds established in the university campus.

Hazardous Waste management: For hazardous waste management the University has taken the following steps A 20 ft deep well (soak pit) is being dug to dump all hazardous waste material in it with standard specification. The outlet of the basins and waste pipes of the laboratories which use radioactive materials is directly connected to the well.

e- Waste management: The e-waste is minimized through (i) The policy of buy-back system the University is following with the suppliers. (ii) If possible upgrading the system before opting for replacement or dumping for the buyback system.

- 1. Title of the Practice: Development of Three Intra-University Independent Museums (Folklore Museum, Department of Folklore and The Fossil Museum, Department of Botany, Museum of Biological Specimens, Department of Zoology) Initiating Collaborations with Other Universities for Sustainable Development
- 2. Objective of the Practice: a. To exhibit the University collections and present to its stakeholders the university history and body of knowledge developed by university personnel. b. To dedicate part or the entire facility as a common study area for PG students, PhD research scholars, UG students of colleges affiliated under the University of Kalyani or elsewhere and support class instructors/ teachers as per their request. c. Multiplication of Benefits from Collaboration between Universities because of the resources exhibited. d. For increasing opportunities for regular interaction and communication among students, teachers and visitors to stimulate ideas and allow projects to "bubble up" from staff, students and faculties engaged in related activities.
- 3. The Context: Museums are considered as key contributors to new knowledge and research. The context behind building up three independent museums were to

provide importance to their teaching and research mission as museums were recognized as essential components of a university of the highest intellectual calibre. 4. The Practice: a. Folklore Museum: Since the inception of the Department has been trying to develop one folklore museum cum archive, which has now been started in a small room and a good number of items of cultural importance have been collected, documented and displayed. Basically, the department gives emphasis to collect materials which are directly connected with folklife. The mentioned department has collected various masks which are used in folk and tribal dances. The department of Folklore is able to collect various silver ornaments, used by the folks, different specimens of Terracotta, scroll paintings of Midnapore, fishing nets and other materials, Suri bowl of Birbhum, wooden dolls, varied folk tools, Naksi kantha, Kalighat paintings, specimens of conch-shell, craft, Dokra and others, rare collection of folk deities etc. In fact, our museum cum archive is the only museum in the University which is visited by scholars, researchers, students for academic purposes. Already this museum cum archive has been found mention in a number of books. This museum has also been appreciated by Ms. Helen G La Fave, US Consul General, Kolkata. b. Museum of Zoological Specimens: A state of art departmental museum has been established for proper preservation of various zoological specimens which are arranged according to their phyla. The scientific classification of each of the species have been put on the specimens by the PG students of the department. The specimens are procured as per identification syllabus of the department and also collected and preserved during the zoological excursion of the students. These specimens have been collected without destroying the biodiversity of the collection area. All the students of the department both PG and PhD students work with the specimens in the museum and the students from various UG colleges visit the museum from time to time. c. Fossil Museum: The Fossil Museum is founded in Palaeobotany, Palynology and Evolution Section of Botany Department, Kalyani University with exciting and thought-provoking displays of nature's treasure trove. Most of these fossils have been collected since a long time by the faculties of the department for their research interest. Later, these collections were placed together forming the fossil museum of the university. The PG students as well as the research scholars work with the specimens with outmost care and the museum is open to all the departments of the university as well as to the UG college students. The department arranges various extension programmes to the school students and college students where the students visit this museum and faculties in the department share their knowledge on palaeobotany with them. It is unusually rich for a small museum and there is a lot of interesting stories of natural history to tell for educating the students and common people about study and its significances in our daily life. The museum houses a wide variety of fossils especially belonging to plant kingdom, collected mainly from Gondwana, Siwalik and Deccan Intertrappean strata of India. Besides, a good collection of plant fossils exhibiting the diversity of Euramarian flora in geological past is showcased to highlight the origin of land plants and their evolution through ages. 5. Evidence of Success: Besides offering regular courses, the museums of the university intend to offer orientation and organize national and international seminar, workshop etc. on folklore and folk life, palaeobotany, Zootaxa, Animal Diversity etc. The University of Kalyani is keen about the academic awareness in inter- provincial and global perspective and for this intends to establish collaboration among different scholars of India and the foreign Universities / Institutes to felicitate an exchange of views between the scholars in inter-disciplinary studies. The University intends to undertake exchange programmes at different levels for strengthening the museums as well as for generating academic interaction and mutual understanding. The success of the museums has been obtained in the form of various international collaborations and international projects. Department of Zoology is working with University of Uzbekistan where a MoU of 3 years have been generated.

Moreover, the exhibits of all the three museums generate a lot of interest amongst students of the university and are generally exhibited to the public on special occasions. 6. Problems Encountered and resources Required: The major problem encountered is the costs of maintaining the museums in the university. The university being a non-profit organization allow free entry in the museums and generating income out of these museums is not possible. So, maintaining the exhibits with proper care is the main challenge that the university faces. Moreover, the tropical weather conditions are not very conducive for preserving different items collected by the departments. But the departments, with their faculty strength try to maintain all the facilities. The main resource required is a resource person/ museologist who would maintain all the three museums as state of art facility of the University of Kalyani, work towards the development of the museums and bring state and central fundings for proper upkeeping of the three museums. 7. To maintain national integrity and progress, the University has been concentrating on such initiatives which are very much relevant to the development and progression of the nations. Considering these aspects, the University has taken the following initiatives: (i) In the University, an atmosphere of communal harmony is preserved promoting the ideas of secularism, national integration and scientific outlook have been promoted with care.
