As per proposal the given by Prof. Rita Ghosh it has also been suggested that towards the end of the day a slot of one hour duration may be kept for the classes of CBCS. Also it was suggested that necessary modification of regulation and corresponding syllabus along with credit system is also to be done.

Agenda 3: Misc.

Regarding collection of data against requirements of various agencies time to time, members suggested that a centralized Data Management System may be adopted. In this regards members unanimously resolved that Centre for Information Resource Management (CIRM) will act as Nodal Centre where a Data Center will be created. All departmental Heads/Section Heads/Centers will forward any transacted data to the CIRM for housekeeping of the same. On requirement of anyone, CIRM will provide the same from the data bank. The statistical cell of the administrative office will be associated to CIRM in this regards. A separate server has been proposed to be installed in the office of the Vice-Chancellor which contains the replica of data of CIRM. In any emergency situation the data will be retrieved for this backup server.
