THE MEMORANDUM OF UNDERSTANDING (M.O.U)

BETWEEN

"THE UNIVERSITY OF KALYANI" a body corporate under the University of Kalyani Act, 1981 (since up to date) as well as read with West Bengal University Law (Amendment) Act, 2011 having its Registered office at 'C' Block and 'B' Block, Kalyani, District: - Nadia, West Bengal, Pin - 741235, hereinafter referred to and called as "K.U" (which term and expression shall unless excluded by or repugnant to the subject or context be deemed to mean and include their heirs, executors, legal representatives or assigns) of the ONE PART.

AND

"Calcutta Business School" (CBS) (a unit of Shikshayatan Foundation) having its registered office at having its office at Diamond Harbour Road Opp. Nilgiri Cinema Hall, Bishnupur, Bara Gagan Gohalia, Kolkata, West Bengal 743503, West Bengal (herein called LP. which shall include its subsidiary companies as well as affiliates companies in life sciences, incorporated by promoters of LP.) on the other part.

PREAMBLE

WHEREAS the K.U has the objective to provide facilities and promote studies and research in emerging areas of higher education on the frontiers of science, technology, and management education. In pursuance of the objective, the

university has been endeavoring to develop closer relationship with the corporate world so that the synergy between academics and business world can be reaped to the fullest extent.

Whereas Calcutta Business School a leading Business School to impart quality education and emerge as a center of excellence providing training to management, students and industry professionals.

NOW, THEREFORE, IT IS HEARBY AGREED BY AND BETWEEN K.U
AND CBS AS FOLLOWS (without any financial liability on behalf of
Kalyani University and Calcutta Business School:

1 SCOPE OF M.O.U:

This M.O.U supersedes all previous correspondence and discussion and understanding taken place between the two parties pertaining to this M.O.U.

2. PERIOD OF M.O.U:

This M.O.U comes into effect from the last date of its signature and will remain in force for a period of 2 years and renewal thereafter or termination before on mutual agreement. Any party to this MOU may withdraw from this MOU after giving a notice of one (1) month.

3. SCOPE OF THE WORK:

The details of the agreement are as given below:

i. Joint Management Development Program (MDP)/Faculty Development Program(FDP)

For Shikat ayatan Foundation Bratati Bhatacharyya Secretary General

- a) The Department of Business Administration, Kalyani University and Calcutta Business School will organize Faculty Development Programme from time to time on the topic(s) to be decided mutually.
- b) The programmes will be offered in online / offline / hybrid mode.
- c) In case of offline mode, venue will be Calcutta Business School / University of Kalyani.
- d) The modalities of offering the programme including choice of resource persons etc., will be decided with mutual consent of both the Institute.
- All funding and revenue sharing matters will be guided by clause 8 of this MOU

4. Management of this M.O.U

For the smooth implementation and operation of this M.O.U, an 'alliance management team (AMT)' shall be formed which would constitute of 4 members with 2 members nominated by each party.

The AMT shall look into various operational aspects and lay down 'specific operating procedures (SOPs)' from time to time.

The SOPs formed and signed by AMT would be binding on both parties till they are not revised or rescinded by AMT.

Both parties will have liberty to change its nominated members to AMT with due intimation to the other party.

5. COMMUNICATION BETWEEN K.U AND CBS

Both parties shall maintain regular communication and exchange data and other information in such manner and frequency as mutually decided on case to case basis. All information exchanged shall be confidential in nature unless the same is in public domain or the recipient has been allowed to treat the

same as non-confidential by the other party. The disclosure of the same shall be governed by the Secrecy Clause of the M.O.U. The mode of communication will include personal meetings, teleconferences, video conferences, emails, postal communications, use of electronic media, etc.

6. OTHER MEASURES TO PROMOTE CLOSER TIES

The KU and CBS shall work together to promote closer interaction between faculty members of KU and faculty members of the CBS through various measures such as organizing joint seminars, workshops, Student competitions etc.

7. SECRECY

It is hereby agreed that the participating agencies shall keep information including but not limited to data, document, structure, formulae, know-how collected completely secret and discloser shall be made on the terms and conditions mutually agreed upon.

8. FUNDING & REVENUE SHARING

- a) If any institute offers the venue to any Third party Institute/Individual, it will charge a reasonable amount for the venue to conduct any program under MDP/JDP.
- If residential accommodation is provided to the participants of the FDP, it will be chargeable separately as per the prescribed rate.
- c) For any programme, faculties will be drawn from both the institutes and they will be paid honorarium of Rs, 2, 000/- (Rupees two thousand only) per session per hour and such honorarium shall be paid from the participation fees collected for the particular FDP.
- d) If required, help of outside experts may also be taken. They will also be paid as per the honorarium mentioned in point no (c) above.
- e) Any surplus generated after charging of all related expenses of the programme will be shared equally between the two institutes.

 In no case there will be any financial liability of Kalyani University and Calcutta Business School.

9. GOVERNING LAW

The law of India shall govern this Contract for the time being in force.
