We are pleased to inform you that IFCI Venture Capital Funds Limited (a subsidiary of IFCI Ltd., a Government of India undertaking) is managing schemes of Ministry of Social Justice and Empowerment, Government of India viz. Venture Capital Fund for Scheduled Castes (VCF-SC) scheme & Ambedkar Social Innovation Incubation Mission (ASIIM). These schemes were operational since 2015 and 2020 respectively.

The VCF-SC supports the potential SC entrepreneurs (including startups) who are in the business of manufacturing, services and allied sectors. Financial assistance in the form of equity, convertible debentures, etc. ranging between Rs.10 Lakhs to Rs.15 Crore is provided for a long tenure of up to 10 years under this scheme.

The ASIIM scheme under the VCF-SC scheme aims to support the young SC entrepreneurs working in the area of innovations and are working in the innovation cells / TBIs in your higher educational institution. ASIIM targets to identify 1,000 innovators till 2024 with startup ideas through the Technology Business Incubators (TBIs) set up by the Department of Science and Technology in various higher education campuses and also the private Incubation cells. The scheme shall support funding such SC owned companies into innovations works of up to Rs.30 lakhs in 3 years span as equity funding, so that they can translate their start-up ideas into commercial ventures. Such new ventures could, upon successful commercialization, apply for venture funding under VCF-SC.

Looking into the growing interest of the young SC entrepreneurs, IFCI has launched the "**Aye Mentor**" Portal (<u>www.aye-mentor.in</u>) in 2022. The beauty of this mentorship portal is that it connects the young SC entrepreneurs minds with the experienced Mentors already registered in the portal. Hence, Aye Mentor aims to help aspiring SC entrepreneurs gain an edge by building their skills, network and gaining experience to up-scale their businesses.

Aye Mentor is the next-gen 1:1 mentoring platform in India bringing together renowned mentors and mentees who need mentoring, where "*first 1000 registered mentees can get up to 10 hours of free mentorship sessions*" from Mentors having vide experience and expertise in various field of business.

At Aye-Mentor the mentees can search for mentors who are experienced in various industries and specializations. The filters are made available to provide better search results. The Mentees can thereafter look for the scheduled availability of a mentor and request to book an appointment.
