CIRCULAR

Urgent attention of the Principals/Officers-in-Charge/Teachers-in-Charge of all State-funded affiliated general degree colleges (except minority institutions) is drawn, for taking immediate necessary action at their end, towards a very recent order [vide Notification No. 354-Edn(CS)/10M-95/14, dt. 02/06/2023, copy enclosed] issued by the Sr. Special Secretary, Dept. of Higher Education (C.S. Branch), Govt. of W. Bengal. In it the procedural and administrative modalities of online admission to UG programmes for the ensuing academic session 2023-24 in State-funded higher education institutions have been clearly enumerated.

Attention is also drawn towards another memorandum [vide no. 339-Edn(CS)/OM-74L/2023, dt. 26/05/2023, copy enclosed) issued by the Sr. Special Secretary, Dept. of Higher Education (Integrated Law Cell), Govt. of W. Bengal. In it the procedural and administrative modalities of introducing reservation of 10% seats in admission for "Economically Weaker Sections" (EWSs) in the State-funded HEIs (except minority institutions) subject to several conditions have been clearly stipulated. It will be implemented from the ensuing academic session 2023-24.

Pursuant to the above, for online admissions for the forthcoming academic session 2023-24 authorities of the State-funded general degree colleges (except minority institutions) under the University of Kalyani are instructed to strictly follow the directions stipulated in the aforesaid G.O.s and other relevant G.O.s/Notification/guidelines issued earlier. The schedule stipulated in the said G.O. No. 354-Edn(CS) are to be strictly adhered to.

In this connection all the affiliated general degree colleges are requested to strictly maintain the intake capacities approved by the University for each programme.

This circular is issued in concurrence with the Vice-Chancellor, vide docket no. VC/102453.
