**The OBC-A/OBC-B candidates belonging to Non Creamy Layer (NCL) only are eligible for consideration as reserved candidates. OBC-A/OBC-B candidates must**

**produce updated NCL certificate.** It must clearly mention that the candidate belongs to Non-Creamy layer and sub-category of OBC-A or OBC-B.

- i) Original annual income certificate of father/guardian(for TFW candidates) in format prescribed by WBJEEB
- j) Duly filled in YES-upgradation form in WBJEEB prescribed format.

  - h) Valid SC/ST/OBC-A/OBC-B certificate issued by the Government of West Bengal, if applicable.  
**The OBC-A/OBC-B candidates belonging to Non Creamy Layer (NCL) only are eligible for consideration as reserved candidates. OBC-A/OBC-B candidates must produce updated NCL certificate.** It must clearly mention that the candidate belongs to Non-Creamy layer and sub-category of OBC-A or OBC-B.
- i) i) Original annual income certificate of father/guardian(for TFW candidates) in format prescribed by WBJEEB
- j) Duly filled in NO-upgradation form in WBJEEB prescribed format.
3. Two Affidavits related to anti ragging compliance (both students copy and guardian's copy) – format attached in the **Appendix I**.
4. The Medical Certificate for General Health, Eye and Blood Group (Original) – format attached in the **Appendix II**.
5. Fee payable at the time of admission in cash – details mentioned in the **Appendix III**.

- candidate must fulfill all the eligibility criteria and the terms and conditions as stipulated by the West Bengal Joint Entrance Examination Board, Govt. of West Bengal,
- candidate must fulfill all the eligibility criteria mentioned in the Regulations for Different Programmes of the Faculty of Engineering Technology & Management, University of Kalyani under the section B For Bachelor's Degree Programme

**D. GENERAL INSTRUCTIONS:**

1. All photocopies MUST be self-attested.
2. If no tuition fee is paid within the scheduled date(s), the candidature may be canceled automatically, without further information.
3. If at any stage of admission the information furnished by the candidate is found to be incomplete, false or incorrect, the University of Kalyani shall have full authority to cancel the admission without further notice.
4. University has limited Hostel seats. For admission to hostel the candidate has to submit physical copy of the duly filled in prescribed form to the DSW, KU. Mere application does not guarantee allotment of hostel seats.
5. For withdrawal of candidature/cancellation, AICTE/University seat cancellation policy is applicable.
