Valid SC/ST/OBC-A/OBC-B certificate issued by the Government of West Bengal, if applicable. **For OBC-A/OBC-B candidates Non Creamy Layer certificates issued on or after 01.04.2023 is mandatory.** It must clearly mention that the candidate belongs to non-Creamy layer and sub-category of OBC-A or OBC-B.

3. Tuition fee: (Approximately Rs. 18,710/-) to be paid only after allotment of seat through debit/credit card or UPI.
