- viii. Valid SC/ST/OBC-A/OBC-B certificate issued by the Government of West Bengal, if applicable. OBC-A/B certificates must be issued on or after 01.04.2024. It must clearly mention that the candidate belongs to non-Creamy layer and sub-category of OBC-A or OBCB.

G. DOCUMENTS TO BE SUBMITTED BEFORE COMMENCEMENT OF CLASSES:

- 1. Two Affidavits related to anti ragging compliance (both students copy and guardian's copy) format attached in the **Appendix II.**
- 2. The Medical Certificate for General Health, Eye and Blood Group (Original) to be obtained only from Gazetted Government Medical Officer / Medical Officer of Government Undertaking in the appropriate letter head of the Medical Practitioner format attached in the **Appendix III.**

H. GENERAL INSTRUCTIONS:

- 1. The students already enrolled in some B.Tech. programmes under University of Kalyani may apply for CSE decentralized counseling. However, if selected, such students have to complete the entire admission procedure. For such students the current seat will be canceled. Refund of the fee against the canceled seat will be as per the University admission cancellation policy.
- 2. The applicants need to keep in mind that the vacancy is subject to change during the counseling process.
- 3. The seats will be allotted strictly on the basis of the WBJEE rank only.
- 4. Any grievances related to the merit list/missing application will have to be reported through email on the same day as the publication of provisional merit list to the email id: admissionug@klyuniv.ac.in along with all supporting documents.
- 5. Candidates have to report at the Department of Computer Science & Engineering, University of Kalyani 15mins before the stipulated time on the day of counseling. Candidature will be canceled if the student is not physically present at the time of reporting and counseling.
- 6. If no fee is paid at the time of admission, the candidature will be canceled automatically.
- 7. If any student fails to complete the admission procedure / submit the mandatory documents on the day of counseling, the candidature is subject to cancellation leading to cancellation of the seat.
- 8. If at any stage of admission the information furnished by the candidate is found to be false or incorrect, the University of Kalyani shall have full authority to cancel the admission without further notice.
