Minimum Eligibility Criteria of Assistant Professor (Full-time Contractual) for M.Sc. course in Computer Science and M.Sc. course in Data Science:

- A Good academic record with at least 55% marks (or an equivalent grade in a point scale wherever grading system is followed) at the MCA/M.E./M.Tech/MS/M.Sc. degree level in Computer Science/ Data Science/ Computer Science & Engineering / Computer Science & Technology and other relevant disciplines from an Indian University, or an equivalent degree from a foreign university with an equivalence certificate.
- The candidate must have cleared the National Eligibility Test (NET) conducted by the UGC/CSIR or similar test accredited by the UGC like NET/SET along with exemptions to specified categories as explained in the **Note- 2**.

Desirable qualification:

2 years post Ph.D. research or two years teaching or three years professional experience in the software industry.

Publications in high impact SCI journals.

Note-1: Relaxation of Marks for Recruitment of Assistant Professor (Full-time Contractual):

- A relaxation of 5% may be provided at the Graduate Masters level for the Schedule Castes / Scheduled Tribes / Differently - abled (physically and visually Differently -abled)/ other Backward Classes (Non-Creamy layer) categories for the purpose of eligibility and for assessing good academic records during direct recruitment to teaching position. However differently-abled (physically and visually) candidates are not eligible for any marks relaxation in Physical Education discipline.
- The eligibility marks of 55% marks (or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible, based on only the qualifying marks without including any grace mark procedure.
- All the essential qualification must have been obtained from a recognized University /Institute. By a University /Institute is meant a University /Institute affiliated to UGC/other statutory apex bodies, or recognized by State or Central Government as a centre for higher learning. In case of a foreign University, the Degree concerned should be recognized as equivalent to its Indian counterpart by the Association of Indian Universities.
- Ph.D. in concerned subject is preferable.

Note-2: NET/SLET/SET Exemption for the post of Assistant Professor (Full-time Contractual):

- 1) The candidates who have been awarded Ph.D. degree in the same or in relevant subject in accordance with the University Grants Commission (Minimum Standards and Procedure for award of Ph.D. Degree) Regulations, 2009 are exempted from the qualifying in the Eligibility Test (NET/SLET/SET).
- 2) Candidates registered for Ph.D. programme prior to 11 July, 2009 shall be exempted from the qualifying in the Eligibility Test (NET/SLET/SET) as described hereinafter;

The award of Degree to candidates registered for the Ph.D. programme prior to 11 July, 2009, shall be governed by the provisions of the then existing ordinances/Bye laws/ Regulations of the institutions awarding the Degree in the same or relevant subject shall be exempted from the requirement of NET/SLET/SET. Subject to fulfillment of the following conditions:

- a) Ph.D. degree of the candidate awarded in regular mode only.
 - b) Evaluation of Ph.D. thesis by at least two external examiners.
 - c) Open Ph.D. Viva-Voce of the candidate had been conducted.
 - d) Candidate has published two research papers from his /her Ph.D. workout of which at least one must be in a refereed journal.
 - e) Candidate has made at least two presentations in conference/seminars, based on his/her Ph.D. work.
- (a) to (e) as above are to be certified by the Vice-Chancellor/Pro-Vice-Chancellor/Dean (Academic Affairs).**

Minimum Eligibility Criteria for Assistant Professor (Full-time Contractual) for B. Tech. [CSE] course:

B.E./B.Tech. and M.E. / M.Tech. / M.S. (At least one degree either at UG or PG level shall be in Computer Science and Engineering / Computer Science and Technology / Information Technology or other relevant disciplines with first class / equivalent credits (marks) at UG and PG in any one of the degrees.)

OR

Integrated M.Tech. in Computer Science and Engineering / Computer Science and Technology / Information Technology or other relevant disciplines with first class / equivalent credits (marks).

OR

B.E./B.Tech. Computer Science and Engineering / Computer Science and Technology / Information Technology or other relevant disciplines with first class / equivalent credits (marks) and Ph.D. awarded is in a relevant discipline by a recognized University following the process of registration, course work and evaluation etc. as prescribed by UGC or has been awarded by the Institutes of National Importance (i.e. IITs / IISc / NITsetc.), duly recognized by the MOE.

OR

The candidates with Ph.D. in computer Science & Engineering along with MCA are also eligible to teach B.Tech. (CSE) programmes along with existing qualifications as prescribed by AICTE for Assistant Professor in Engineering and Technology.

Desirable qualification:

- 2 years post Ph.D. research or two years teaching or three years professional experience in the software industry.
- Publications in high impact SCI journals.

General instructions to the candidates

- a. **Application fees: Rs.1000/-for General (non-refundable)

- b. **Age: As per G.O.No.1081-Edn(U)/1U-91/10 dated 15.12.2021**
- c. A person working in Govt./Semi Govt./Public Sector undertaking must apply through proper channel.
- d. The University shall reserve the right to cancel the process of recruitment to any category of the above mentioned post without showing any reason whatsoever.
- e. The University of Kalyani shall reserve the right of rejecting any or all the applications without assigning any reason thereof.
- f. Mere eligibility will not vest any right on any candidate for being called for interview / in any other form of selection process. Only the short listed candidates will be called for an interview. The decision of the University in all matters will be final.
- g. No informal correspondence from the candidates will be entertained in connection with the process of selection. Canvassing in any form will entail disqualification of candidature.
- h. In case of improper information regarding the qualification/experience found at any stage, the candidature of a candidate shall be rejected.
