1. General Instructions:

In the event of e-tendering, intending bidder may download the tender documents from the website: http://wbtenders.gov.in directly with the help of Digital Signature Certificate (DSC)or from the University of Kalyani's website www.klyuniv.ac.in.

2. Submission of bids:

Both Technical bid and Financial Bid are to be submitted concurrently duly digitally signed by the Company personnel who is in the pay roll of the Company (having Authorization from the Company management) in the website http:// wbtenders.gov.in. All papers must be submitted in English language.

3. Time Schedules for the e-tender:

The Time Schedule for obtaining the Bid Documents, Pre Bid meetings, the submission of bids and other documents etc. will be as per the list provided in Clause No.10 given below.

4. Eligibility for Quoting:

- a) The bidder should submit list of customers to whom similar equipment were supplied in recent past at least during the last 5 years along with names & full addresses of the customers indicating order reference etc.
- b) Bidder and OEM Should have local support center
- c)Further, Bidder who was declared black listed and/or insolvent by any Govt. Concern/any Institutions in the Country for particular item or items are not eligible to participate in the current tender for that item or items.

5. Annual Turnover Requirements:

Vender having average annual Turn Over for last three financial years is not less than Rs.20 Lakh in India for the year 2021-22, 2022-23 & 2023-24 in the said financial years are eligible to participate in the Tender.

6. Submission of Tenders

6.1 General process of submission

Tenders are to be submitted online through the website stated in Clause1. All the documents uploaded by the Tender Inviting Authority form an integral part of the contract. Tenderers are required to upload all the tender documents along with the other documents, as asked for in the tender, through the above website within the stipulated date and time as given in the Tender. Tenders are to be submitted in two folders at a time, one is Technical Bid and the other is Financial Bid. The tenderer shall carefully go through the documents and prepare the required documents and upload the scanned documents of originals in Portable Document Format (PDF) to the portal in the designated locations/folders of Technical Bid. He needs to fill up the BOQ in the designated cell and upload the same in designated locate on of Financial Bid. The documents uploaded are virus scanned and digitally signed using the Digital Signature Certificate (DSC). Tenderers should specially take note of all the addendum/corrigendum related to the tender till the bid submission ends. Tenderers should in general upload the latest documents as part of the tender, however, in case of failure in uploading such documents, it will be deemed that they (tenderers) have taken note of such latest documents including addendum/corrigendum, if published till the bid submission ends.

6.2 Technical Bid

- 3. Bidder must submit their documents through the appropriate folders as stated above. Submission of document not through proper folder(s) may be considered as non-submission. If University fails to identify the document because of such wrong submission or due to submission of documents not readable visibly or for any technical issue like not opening the files etc., it would be deemed that the bidder did not submit that particular document(s).
- 4. Others: Any other documents found necessary

6.3 Financial Bid

The Financial Bid should contain the following document in one cover (folder):

- a) <u>Bill of Ouantities (BOO)</u>: The tenderer should fill-up the designated cell as marked by the University in the BOQ sheet.
- b) <u>For Car Service</u>: Bidder must quote the Basic Rate that includes Driver's Salary per day. Overtime Duty Rate will be allowed per day over 10 hours of service. University follows Dry System on <u>Garage in Garage Out (GIGO)</u> basis. For other details, kindly refer Clause No. 9.7 of the Terms & Conditions. GST, if any, should be included both in Basic Rate and Overtime Duty Rate.
- c) <u>For Bus Service</u>: Bidder must quote the Basic Rate for a month comprising 22 days in a month and seven (7) Trips per day that includes Driver and Helper Salary per day and all other incidental costs. GST, if any, should be included in Basic Rate and Overtime Duty Rate.
- 7. The tenderers are not required to submit hard copies of Technical File (Statutory) or My documents (Non-Statutory). Submission of hard copy of Financial Bid is strictly prohibited and only be submitted through on line through NIC portal.

8. Evaluation of the tenders

During the tender evaluation process, the "Technical Bid" will be opened first. Those Bidders who have qualified in respect of the essential & other requirements in "Technical Bid" will be identified and their financial bid will be opened. The financial bid of those Tenderer failing to meet the technical & other requirements laid down in the tender will not be opened and be rejected. The Tenderer offering the item found suitable and as per the tender specifications will only be selected. Final selection of the bidder in respect of Financial Bid is subject to further verification of several parameters allied with Financial Bid Evaluation. The Financial Bids of only those tenderers who have been considered as Technically Qualified will be opened.

9. TERMS & CONDITIONS REGARDING PURCHASE POLICY OF TENDERINGAUTHORITY:

9.1 Bid Information:

- a) Bidder must quote in INR in the BOO Sheet.
- b) The rate quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- c) Bidder must follow the instruction for filling up BOQ as per Clause 6.3.
- Bidder may quote either for car or bus or both. Further, bidder may quote for one (1) or two (2) or three (3) cars.

- **9.2 Evaluation** of Quotation: The Purchaser will evaluate and compare the quotations determined to be substantially responsive stage wise. Firstly, Technical Bid will be evaluated and thereafter Price Bid for technically qualified bidders will be evaluated for selection of vender.
- **9.3 Award of Contract**: The purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive both technically and commercially for both the equipment. Purchaser reserves the right to reject any or all the tender, wholly or partly, without assigning any reason thereof and shall not be bound to accept the lowest bid.
- 9.4 University enjoys the discretion to select vendor either in full or in part (item wise) for the betterment for pursuing of tender objectives.
- **9.5** The bus and at least one car must have valid **Commercial** RTO registration. It should not be more than 7 years old. The vehicle must be in good condition. University reserves the right to ascertain the number of car to be plight and accordingly may scrutinize the documents of the quoted car.
- **9.6** Hire charge of the dry car shall be quoted per day basis. For Bus, the quote must be made on monthly basis for seven trips a day and 22 days in a month. This may vary depending upon the actual scenario.
- **9.7** For Cars, cost of petrol/diesel & lubricants along with monthly bill shall be paid by the University considering prevailing rate of ordinary petrol/diesel cost at a rate 10 km/8km per 1 litre and 1 liter mobil oil per 500 kms. run.
- **9.8** The car/bus owner will have to bear driver's remuneration, repairs & maintenance of the car/bus and all other incidental expenditure. University will not bear any liabilities in this regard.
- **9.9** Bidder should submit copy of updated Trade License, GST, IT and P. Tax Return submission document.
 - **9.10 Credentials**: Documents of similar type of work in last 5 years (2019-20,2020-21,2021-22,2022-23 & 2023-24) in a Recognized Institute of Higher Learning or Government offices must be submitted along with the tender. Bidder must submit User List with copy of Work Order pertaining to the said service.
- **9.11** Statutory deduction for TDS as per Income Tax Act will be made as per the law in force.
- **9.12** The car/bus provider should possess valid documents of ownership, Blue book/Registration papers, MV Tax, Insurance, Permit, Pollution Certificate, driving license of the driver, and others, if required any of the car.
- **9.13** Overtime charge will be paid on hourly basis beyond 10 hours of duty. Car owner has to mention the rate in the quotation.
- **9.14** The car/bus will remain under the supervision and control of the University Engineer from time to time, for its plying to serve the university purpose.

- 9.15 In case of exigencies, the car will be used beyond the hours mentioned above and on Saturdays, Sundays & holidays. If required, the car may be used to go anywhere as directed by University Engineer. However, normal charges for first 10 hours and overtime charge will be paid on those days also.
- **9.16** University reserves the discretion to issue work order either in full or phase wise depending upon the requirement.
- **9.17** The driver of the car/bus must be polite, obedient and must have valid license and having experience of plying car/bus. He will have no connection with the University service and his service will not be considered as on 'duty' of the University like other employees of the University. In case of change of driver of the car/bus, prior intimation should be given to the authority of the university by the vender.
- **9.18 Payment Schedule**: Payment be made after successful service duly authenticated by the university in Log Book and Bill.
- 9.19 Copy of documents of car/bus should be submitted in Technical Folder.
- **9.20** The driver for car/bus should not be found intoxicated during working hours.
- **9.21 Requisite Documents to be submitted:** Bidder must have adequate documents relating to Trade License and updated returns for Income Tax, GST, Audited Statement of Accounts and other documents.
- **9.22** All the documents of car/bus in original or duplicate must be kept with the driver and the Original has to be presented as and when will be required.
- **9.23 Disposal of Disputes**: In case of any dispute, the University's decision will be treated as the final and conclusive. All legal actions are subject to Kolkata jurisdiction only.
- **9.24** Conditional bid may be liable for rejection.
- **9.25** The driver of the car/bus should maintain the log book duly filled in regularly and Signed by officer/ authorized person using the car/bus and countersigned on Verification by the University Engineer.
- **9.26** Conflict of Interest: Not more than one tender shall be submitted by one tenderer or tenderers having relationship. Under no circumstances will father and son(s) or other close relations who have business relationship with one another (i.e. when one or more partner(s)/director(s) are common) be allowed to tender for the same contract as separate competitors. A breach of this condition will render the tenders of both parties liable for rejection.
- 9.27 Bill in triplicate will have to be submitted within 1st week of the following Month to the University Engineer along with log book duly filled up and signed by user(s). Payment will be made after statutory deduction, if any.

- **9.28** In case of breakdown, the car/bus owner will have to make alternative arrangement for a similar car at his own cost, failing which contract amount per day may be deducted from monthly bill as penalty.
- 9.29 The agreement between the university and the Car/bus hire agent will be made initially for one (1) year though university reserves the right to renew/ extend the said term or to cancel the agreement after serving notice prior to 1 month before completion of the period of engagement.
- 9.30 In case of **Tie Bid** arising after opening of price bid, University will follow the guideline as mentioned in the G.O. No. 2320-F(Y) dated 7/6/2022 issued by the Finance Department, Government of West Bengal.

9.31 Discretion of the University:

- (i) University may take decision about non-purchase of the said item even after selection of vendor due to its fund constraints.
- (ii) University may seek documents from the bidder in addition to the scanned documents sent by the mat the time of uploading technical bid for verification and evaluation of tender.
- (iii) For any false/unethical/illogical/unreasonable bid, University reserves the right to cancel the bid even after opening of Price Bid.
- (iv) In case of tie bid item-wise or for all the items between two or more bidders, University reserves the right to select bidder in strict observance of the existing orders of the Government of West Bengal, if any.
- (v) University reserves the right to relax any clause as stated herein above for selection of responsive vender.
- (vi) University also possesses the right to include/exclude/modify terms & conditions at the time of engagement/renewal /extension of service.
- 10. Opening the financial bid as per schedule will BE NOTIFIED LATER ON.
 - Financial bid can be seen & accessed by the bidder through the NIC Portal online after opening of financial bid on line. No objections raised by any Bidder in this respect will be entertained by the University. No informal tender will be entertained in the Bid further.
- 11. During the scrutiny, if it comes to the notice to tender inviting authority that the credential or any other paper found incorrect/ manufactured/ fabricated, that bidder would not allowed to participate in the tender and that application will be rejected outright without any prejudice.
- **12.** The Tender Selection Committee reserves to right to cancel the N.I.T. due to unavoidable Circumstances and no claim in this respect will be entertained.
